- 1. Hire an acoustic consultant. Our options are Kerri Standlee or Rand Acoustics. Tom made a motion to table hiring an acoustics consultant until further information can be obtained. Amy seconded motion. Motion passed

### New Business:

- 3. Approve the estimate for Long's propane contract in the amount of \$1.49 a gallon. Amy made a motion to approve the Long's contract. Tom seconded the motion. Motion passed
