### **Committee Reports**

- Eric Tester Board Liaison: reports that PC and ZBA secretary pay increased by \$50 per meeting, the board wants the PC to do the legwork on permit application updates, and he took the proposed resolution on Citizens for Local Choice to the board. They did not take any action on it.
- Dave Kelsey Zoning Administrator: There has been one permit for a dwelling which
  was denied due to setbacks from the road. ZBA will be contacted for variance. He also
  reports that he will be going to court in two weeks on a blight issue.

#### **Old Business**

- Building permit process: PC reviewed samples of permit applications from local townships: Cato, Reynolds, Belvidere, and Pierson. Consensus was reached that ideas from portions of Belvidere and Reynolds township applications would cover what Douglass township is looking for, as well as add a section for surveys. The surveys would be required for permanent structures, such as house, garage, barn. Kathy Craig will work on this and send it to the board for review.
- Items to work on going forward: PC needs to find the document Dave Kelsey is using for timelines of violations (92-2), as it is not in current zoning book or on the website, Lake Stanton high residential district, campers, short term rentals.
